Mayor Dormier called the Council Meeting of the Ovilla City Council to order at 6:30 PM, in the Ovilla Council Chamber Room, 105 S. Cockrell Hill Road Ovilla TX 75154, with notice of the meeting duly posted.

ITEM 2. DISCUSSION/ACTION – Consideration of and action on a replat request, filed by Erwin and Rosanna Ramos to replat 0.9982-acres. The replat is on 0.992-acres, on the owner's 3.04-acre tract of land, Lot 4 Block D, Westmoreland Road Estates No. 2, in the City of Ovilla, in Ellis County, Texas.

The Council discussed the applicant's proposal to divide .9982-acres from the 3.0352 total acres for residential purposes. Staff noted that fifteen letters to homeowners within 200 feet were mailed and All other postings (newspaper) legal requirements had been met.

PL5 Myers moved that to approve Re-Plat #2021-02 application submitted by Erwin & Rosanna Ramos (owner) to replat 0.9982-acres of the 3.0352 total acres, Lot 4 Block D, Westmoreland Road Estates No. 2, more commonly referred to as 707 Georgetown Road, in the City of Ovilla, Ellis County, Texas. ITEM 3. DISCUSSION/ACTION – Consideration of and action on the request from, AGC, to waive double permit charges due to construction beginning prior to the issuance of building permits.

City Staff presented the Council with documentation and photographs which showed construction had started at two locations by AGC Custom Homes. The Council discussed with Staff recommendations for the permit fees and options to be sure the developers are aware that permit fees are to be charged double per the fee schedule if construction begins prior to obtaining a building permit. Angel Gonzalez, the owner of AGC Custom Homes, addressed the Council and asked that the double permit charges be waived.

Mayor Pro Tem Hunt made a motion to waive double permit fees, and assess the fees at the regular rate of \$2,400 for 7420 and 7430 Desert Willow LN.

PL2 Oberg seconded the motion.


1. PL1 Huber announced that she had been in contact with Kyle Butler and that a guard rail had been installed on the Water St. Bridge.


